AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Columbia School District No. 400 from September 1, 2014 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Compliance with Career and Technical Education requirements
- Controls over payroll disbursements
- Review of new employee files and signficant payroll increases
- Self-insurance reporting and controls
- Review of general disbursements for compliance with district policy, adequate support, and valid purpose
- Review of third party receipting procedures for school fees
- Review of IT security risks

INFORMATION ABOUT THE DISTRICT

Columbia School District No. 400, located in Walla Walla County, serves approximately 875 students in kindergarten through 12th grade. The District provides a full range of school programs and services including basic elementary, middle school, high school, vocational education, pupil transportation, food services and special education.

An elected, five-member Board of Directors governs the District's operations. Directors serve staggered, four-year terms, The Board appoints a Superintendent who is responsible for day-to-day operations and its approximately 120 employees. For the 2015 and 2016 school years, the District's expenditures were approximately \$12 million each year.
