AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Cheney from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meeting minutes
- Contracts/agreements
- Use of restricted funds grants
- Financial condition
- Department review Municipal Court

INFORMATION ABOUT THE CITY

The City of Cheney was incorporated in 1883 and serves approximately 11,400 Spokane County residents. It provides public safety, Municipal Court, fire protection, emergency medical, building code enforcement, street improvement, parks and recreation and general administrative services. The City also provides utility services including water, sewage collection and disposal, light and sanitation.

An elected, seven-member Council with a separately elected Mayor governs the City. The Mayor oversees the City's daily operations as well as its 92 employees. The Council sets policy, budget and utility rates. For fiscal year 2016, the City operated on an annual budget of approximately \$27.7 million.
