AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Boistfort School District No. 234 from September 1, 2015 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- Financial condition
- Enrollment

- Surplus of assets
- Payroll
- Self-insurance

INFORMATION ABOUT THE DISTRICT

Boistfort School District No. 234 provides educational services to approximately 91 full-time-equivalent students in pre-kindergarten through eighth grade.

The District has one elementary school and is governed by a Board of Directors. The District operates on an annual budget of \$1.5 million.
