AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Kelso from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility billing and adjustments
- Cash receipting
- Use of debt proceeds
- Financial condition

- Payroll
- Disbursements
- Building permits

INFORMATION ABOUT THE CITY

The City of Kelso serves approximately 11,970 citizens. The City provides services including police, streets, sanitation, recreation, library, public improvements, planning and zoning, water supply treatment and distribution, and sewage and storm-water collection and treatment.

An elected, seven-member Council governs the City. The Council selects a Mayor from among its members to serve a two-year term. The Council appoints a Manager to oversee the City's day-to-day operations as well as its 70 employees. For fiscal year 2016, the City operated on an annual budget of approximately \$38 million.
