AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Franklin County from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Review of controls and safeguarding of small and attractive assets
- Review of payments/expenditures for compliance
- Compliance with District policy over payroll disbursements, overtime and cash outs
- Compliance with state law requirements over procurement (bidding/prevailing wage)

INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Franklin County was established in 1934 to purchase, generate, transmit, distribute and sell electric energy. The District's service area covers approximately 435 square miles in Franklin County. Serving approximately 28,400 accounts, the District provides services to approximately 80 percent of the County's population.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Manager to oversee the District's daily operations as well as its approximately 90 employees. For fiscal year 2015 and 2016, the District received revenue of approximately \$86 million and \$84 million, respectively.
