## AUDIT SUMMARY

### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated August 8, 2017, related to Career and Technical Education reporting. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of Nine Mile Falls School District No. 325/179 from September 1, 2014 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Teacher education and experience (staff mix) reporting
- Student enrollment reporting (career and technical education)
- Safeguarding of small and attractive assets such as computers
- Insurance/risk management

## INFORMATION ABOUT THE DISTRICT

Nine Mile School District No. 325/179 serves more than 1,350 students in kindergarten through 12th grade in Spokane and Stevens Counties. The District has two elementary schools, one middle school and one high school.

A five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations and its approximately 200 employees. The District operates a general fund annual budget of approximately \$15.9 million for fiscal year 2016 and \$14.8 million for fiscal year 2015.
