#### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Skamania County from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Utility billing
- Cash receipting, including adjustments
- Controls over fuel and inventory
- General disbursements
- Procurement of engineering awards
- Cost allocation between utilties

#### INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Skamania County, Washington is a municipal corporation established in 1938 by a vote of the people of Skamania County. The District exists under and by virtue of RCW 54 for the purpose of distribution, and sale of electric energy and water. The District operates three separate systems named Electric Distribution System, Carson Water System, and Underwood Water System. Although the District owns small portions of generation facilities, all electric power is purchased from the Bonneville Power Administration under a Full Requirement contract. The District serves approximately 5,900 electric and 1,300 water customers in Skamania County.

An elected, three-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its 27 employees. The District generated revenues of approximately \$11.7 million for fiscal year 2016.
