AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Benton-Franklin Health District from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements
- State grant compliance
- User access controls over New World
- Credit card transactions
- Third party receipting

INFORMATION ABOUT THE DISTRICT

The Benton-Franklin Health District serves approximately 246,000 citizens in Benton and Franklin counties. The District provides environmental health services including food services, worker permits, solid and liquid waste permits, swimming pool testing and public water testing. Personal health services provided by the District include infant immunization, nutrition, education, vital records and disease prevention and detection.

Prior to 2008, the District was governed by a 13-member Board of Health. Since January 1, 2008, the District now operates under a six-member Board. Board membership consists of three Commissioners each from Benton and Franklin Counties. Revenues were \$9,653,502 and \$9,089,374 in 2016 and 2015, respectively. Expenditures were \$9,089,374 and \$8,866,872 in 2016 and 2015, respectively.
