## AUDIT SUMMARY

### Results in brief

In the areas we audited, Transit Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Transit Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Clallam Transit System from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Transit Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Cash receipting – vanpools
- General disbursements
- Open purchase accounts/fuel cards
- Payroll disbursements
- Overtime
- Fuel

## INFORMATION ABOUT THE TRANSIT AUTHORITY

The Clallam Transit System (Transit Authority) provides public transportation services for approximately 71,400 citizens in Clallam County. The Transit Authority is a public transportation benefit area (PTBA), a municipal corporation of the State of Washington. The Transit Authority is governed by an eight-member voting Board, composed of two County commissioners and two elected officials from each of the three incorporated cities located within the county: Port Angeles, Sequim, and Forks, plus one nonvoting appointed union member from Amalgamated Transit Union (ATU), Local 587.

The Board appoints a General Manager to oversee the Transit Authority's daily operations as well as its 82 full-time equivalent employees. For 2016, the Transit Authority had an operating budget of \$8.4 million and a capital project budget of \$1.5 million. The Transit Authority provides fixed-route, complementary Americans with Disabilities Act, paratransit, vanpool, and dial-a-ride services.
