## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the North Kitsap Fire and Rescue from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- General disbursements
- Accounts receivables
- Self-insurance

## INFORMATION ABOUT THE DISTRICT

Kitsap County Fire Protection District No. 10, doing business as North Kitsap Fire and Rescue, provides fire prevention and protection to approximately 22,000 Kitsap County citizens. The District's service area covers 47 square miles that includes the communities of Kingston, Indianola, Suquamish, Miller Bay and Hansville.

A five-member Board of Commissioners governs the District. Commissioners are elected to staggered, six-year terms. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 45 career employees and 21 volunteers. The District receives the majority of its funding through property taxes. For 2015 and 2016, the District operated on a budget of approximately of \$7.4 million each year.
