#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Wahkiakum Conservation District from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Credit card disbursement
- Cost allocation

- Payroll
- Disbursements

## **INFORMATION ABOUT THE DISTRICT**

The Wahkiakum Conservation District was established in 1940 for the purpose of promoting conservation services and education to Wahkiakum County residents.

A five-member Board of Supervisors oversees the District. Three members are elected by the landowners within the District and two are appointed by the Washington State Conservation Commission. During 2016, there were four active Board Members and one vacant position. The District contracts with the Cowlitz Conservation District for shared operations. The District only has one employee with Cowlitz Conservation District providing the District Manager, bookkeeper and one other position through the interlocal agreement. State and federal sources primarily fund the operations of the District and there are no locally generated revenues. The District received operating revenues of \$529,187, \$506,341 and \$375,144 during 2014, 2015 and 2016, respectively.
