AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Lincoln County Conservation District from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Financial condition

- Payroll/personnel
- Conflict of interest/ethics laws

INFORMATION ABOUT THE DISTRICT

Lincoln County Conservation District was established in 1975 by the merger of four conservation districts in the county. It is one of 47 conservation districts in the state. The District provides conservation and educational services about natural resources to the general public.

A five-member Board of Supervisors governs the District. Three members are elected and two members are appointed by the State Conservation Commission. The District has four employees and for the past three fiscal years has operated on annual budgets of \$710,750 in 2014, \$720,750 in 2015 and \$823,750 in 2016.
