AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated November 8, 2017, related to compliance with state law regarding procurement requirements for public works projects and architecture and engineering services. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Franklin County Irrigation District No. 1 from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Compliance with procurement of architecture and engineering services
- Compliance with procurement of public works projects
- Review of general disbursements for adequate support, proper approval, and allowable business purpose.

INFORMATION ABOUT THE DISTRICT

Franklin County Irrigation District No. 1 was formed in 1919 to supply irrigation water to homes and farms in a rural section of Franklin County, west of the city of Pasco.

An elected, five-member Board of Directors administers the District. Each Board Member serves a three-year term. The Board appoints an Operations Manager to oversee District operations and its five employees. The District's revenues were \$1.35 million for 2015 and \$1.40 million for 2016.
