AUDIT SUMMARY

Results in brief

In the areas we audited, County operations complied with applicable requirements and provided adequate safeguarding of public resources. The County also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Lincoln County from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the County's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Insurance/risk management
- Use of restricted funds
- County Fairgrounds financial operations
- Sheriff Department
- Payments/expenditures
- Safeguarding of small and attractive assets such as computers
- Cash receipting
- Contracts/agreements

INFORMATION ABOUT THE COUNTY

Lincoln County was incorporated in 1883 and currently serves approximately 10,300 citizens. The County is administered by three elected Commissioners, each representing separate districts within the County. The County has eight additional elected positions including: Assessor, Auditor, District Court Judge, Prosecuting Attorney, Sheriff, Superior Court Clerk, Superior Court Judge and Treasurer.

The County operated on a \$31.2 million annual budget for 2015 and a \$29.1 million annual budget for fiscal year 2016. Its approximately 150 full-time employees provide an array of services including public safety, road improvement, judicial administration, health and social services, solid waste disposal and land use planning and permitting.
