#### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Chelan Fire and Rescue from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

Chelan County Fire Protection District No. 7, doing business as Chelan Fire and Rescue, was established in 1955 to provide fire prevention and suppression services, emergency medical aid and protection of life and property to residents living within its service boundaries. The District operates five fire stations staffed with 17 full-time employees and approximately 35 volunteer firefighters.

An elected, three-member Board of Commissioners governs the District. The District had an annual revenue of approximately \$2.1 million in 2016.
