AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Benton County Fire Protection District No. 4 from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billing & receipting accuracy of emergency medical services
- Compliance with third-party receipting requirements
- Use of small works roster for public works projects
- Use of Federal grant funds
- Payroll processes and procedures
- Payroll payments
- Procurement for purchase equipment and vehicles

INFORMATION ABOUT THE DISTRICT

Benton County Fire Protection District No. 4 was formed in 1953 to provide fire protection and fire suppression services and emergency medical services for citizens of central east Benton County. This service area covers approximately 52 square-miles between the cities of Richland and Benton City.

An elected, three-member Board of Commissioners governs the District. Three full-time employees and approximately 30 volunteers conduct the District's operations. The District received revenue of approximately \$2,937,695 in 2014, \$3,105,217 in 2015 and \$3,743,590 in 2016. Benton County Treasurer serves as the Treasurer for the District.
