### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Cowlitz 2 Fire and Rescue from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll disbursements
- General and credit cards disbursements
- Self-insurance programs

- Procurement of public works projects
- Cash receipting

## INFORMATION ABOUT THE DISTRICT

Cowlitz 2 Fire and Rescue was created in 1947. The District provides fire protection and emergency medical services for approximately 40,000 residents in a 170 square-mile area in Cowlitz County. The District operates five stations, which are staffed by 41 full-time permanent employees five part-time employees and one full-time temporary employee. The District has between 60 and 80 volunteers at any given time.

An elected, five-member Board of Commissioners governs the District. The District levies taxes and collects emergency medical service transportation fees to support its operations. For fiscal years 2015 and 2016, the District budgeted approximately \$6.5 million in annual revenues per year.
