AUDIT SUMMARY

Results in brief

In the areas we audited, Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Odessa Public Development Authority from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Cash receipting

INFORMATION ABOUT THE AUTHORITY

Odessa Public Development Authority was formed in 2000 and is located in Lincoln County. The Authority's main purpose is to assist the community through the creation of jobs.

A seven-member Board of Directors governs the Authority. Directors are approved by the Town Council. The Authority has two part-time employees and all Directors are volunteers. The Authority had operating revenue in the amounts of \$555,000, \$240,000 and \$197,000 in fiscal years 2014, 2015 and 2016, respectively.
