## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the City of Burien from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding)
- Credit cards
- Travel expenses

- Cash receipting
- Financial condition

## INFORMATION ABOUT THE CITY

The City of Burien was incorporated in 1993 in King County. An elected, seven-member Council governs the City. The Council elects one member to serve as Mayor to preside over the Council for a two-year term. The Council appoints a Manager to oversee the City's daily operations as well as its approximately 74 full-time employees.

The City of Burien serves approximately 50,000 residents. The City provides a range of services to the public, either directly or through contracts with other governmental agencies including municipal court, police, jail, public works, planning and community development, parks, recreation and cultural, library, fire, water and sewer services. In fiscal year 2016, the City's general fund operating budget was \$24 million.
