## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Central Kitsap Fire and Rescue from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Self-insurance for unemployment
- Cash receipting

- Payroll disbursements
- Ambulance fee refunds

## INFORMATION ABOUT THE DISTRICT

Central Kitsap Fire and Rescue was established in 1942 and provides fire protection and emergency medical services in Kitsap County. The District service area covers 115 square-miles and serves approximately 69,912 citizens in the Silverdale area.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 106 employees and approximately 48 volunteers. For fiscal years 2015 and 2016, the District operated on an average annual budget of approximately \$16.5 and \$17.4 million, respectively.
