AUDIT SUMMARY

Results in brief

In the areas we audited, Board operations complied with applicable requirements and provided adequate safeguarding of public resources. The Board also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Spokane County Noxious Weed Control Board from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Board's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Insurance/risk management

- Payroll/personnel
- Payments/expenditures

INFORMATION ABOUT THE BOARD

Spokane County Noxious Weed Control Board was established in 1970 to provide noxious weed control oversight and enforcement for all of Spokane County. Spokane County Commissioners appoint the five-member volunteer Board. Board Members serve four-year terms.

The Board operated on annual budgets of approximately \$400,000 for each of the three years audited. The Board employs two full-time and eight to nine seasonal employees who provide education, technical assistance and control of noxious weeds through voluntary compliance and enforcement.
