AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated November 29, 2017, related to safeguarding of assets. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of WhidbeyHealth from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Pharmacy
- Small and attractive assets
- Cash receipting
- Contracts and agreements

INFORMATION ABOUT THE DISTRICT

The Whidbey Island Public Hospital District, doing business as WhidbeyHealth, is located in Island County. The District provides comprehensive health care that includes professional nurses, physicians and support staff in Coupeville and seven provider locations on the north and south end of Whidbey Island. These satellite locations provide affordable quality healthcare to Whidbey Island's under or uninsured population.

The District is governed by an elected, five-member Board of Commissioners. The Board appoints the CEO to oversee the District's daily operations as well as its approximately 800 employees. In fiscal year 2016 the District operated on an expense budget of approximately \$99.8 million.
