#### AUDIT SUMMARY

#### **Results in brief**

In the areas we audited, Hospice operations complied with applicable requirements and provided adequate safeguarding of public resources. The Hospice also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Hospice of the Northwest from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Hospice's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Third party billing
- Payroll
- Travel

- Financial condition
- Open Public Meetings Act

The current Skagit Hospice LLC, doing business as Hospice of the Northwest, was created in 2003 through an interlocal agreement between Skagit County Public Hospital District No. 1, doing business as Skagit Valley Hospital, and Skagit County Public Hospital District No. 304, doing business as United General District 304. Skagit Hospice has been providing hospice care to residents of Skagit, Snohomish, Island and San Juan counties since 1989.

A four member Executive Council serves as the governing board and oversees about 70 Hospice employees.
