AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated December 1, 2017, related to interfund loans. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Yakima from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll overtime and retirement payouts
- Procurement and bid requirements
- Travel and credit cards use
- Third party cash receipting
- Fire department fuel use
- Financial condition
- Utility billings

- Interfund transfers and loans
- Cash receipting Vanpool, Lion and Franklin Park swimming pools
- Safeguarding of small and attractive assets
- Open Public Meetings Act
- Interlocal agreement with Yakima County for jury services

Financial

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements. That report is available on our website, http://portal.sao.wa.gov/ReportSearch.

That report includes a finding for a material weakness in internal controls over financial reporting regarding the major fund calculation.

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE CITY

The City of Yakima serves approximately 92,000 citizens in Yakima County. It operates as a first class city under the council-manager form of government. The City Council consists of seven Council Members, four of whom are elected from separate districts, and three elected at large. The Council, from within its own membership, chooses the Mayor every two years.

The City provides a full range of municipal services. These services include public safety (police, fire, Municipal Court), public improvements (streets, traffic signals, storm sewer), sanitation (solid waste disposal, sewer utility), water utility, community development, parks, recreation, code enforcement and general administrative services. The City has approximately 770 employees. For fiscal year 2016, the City operated on a total budget of expenditures of approximately \$223 million.
