AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated December 7, 2017, related to the cost allocation plan. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Sumas from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cost allocation plan
- Municipal court receivables controls
- Police Department review

- Safeguarding of assets
- Fuel usage

INFORMATION ABOUT THE CITY

The City of Sumas was incorporated in 1891 and currently serves 1,571 citizens in Whatcom County. The City provides general administrative services including water, sewer, electric, cable television, police, Municipal Court, cemetery and parks.

An elected, five-member Council and an independently elected Mayor govern the City. The Board appoints management to oversee the City's daily operations as well as its 25 full-time employees. For fiscal years 2015 and 2016, the City operated on annual budgets of \$6.97 million and \$7.06 million, respectively.
