AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Snohomish County Fire Protection District No. 12 from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Safeguarding of small and attractive assets
- IT data backup and recovery

- Self-insurance
- Bid law compliance follow up

INFORMATION ABOUT THE DISTRICT

Snohomish County Fire Protection District No. 12 is a special purpose government that was incorporated in 1952. In 1992, the District entered into an interlocal agreement with the City of Marysville to create the Marysville Fire District. In 1998, Snohomish County Fire Protection District No. 20 consolidated into Fire District No. 12 and in 2002, Fire District No. 20 merged into Fire District No. 12.

A three-member Board of Commissioners governs District operations. The District covers approximately 54 square miles including the city of Marysville, Seven Lakes, Quilceda Village and the east side of the Tulalip Indian Reservation, as well as portions of unincorporated Snohomish County.

Beginning in 2015, the operations of the Marysville Fire District were combined with the District's. The District acts as the fiscal agent on behalf of the Marysville Fire District. The District's operating expenditures for fiscal year 2015 were \$2,725,266, and for fiscal year 2016 were \$2,778,038. The operating expenditures for the Marysville Fire District were \$15,498,979 for the 2015 fiscal year and for the 2016 fiscal year were \$16,457,167.
