### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Jefferson County Fire Protection District No. 4 from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial reporting
- Narcotics inventory

- Payments/expenditures
- Financial condition

## INFORMATION ABOUT THE DISTRICT

Jefferson County Fire Protection District No. 4 provides fire protection, suppression and emergency services (EMS) to the citizens of Brinnon and the surrounding areas of Jefferson County.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's operations as well as its three employees and approximately 16 volunteers. The District reported operating revenue of approximately \$451,000, \$589,000 and \$564,000 for 2014, 2015 and 2016, respectively.
