AUDIT SUMMARY

Results in brief

In the areas we audited, Alliance operations complied with applicable requirements and provided adequate safeguarding of public resources. The Alliance also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Smokey Point Medical Center, LLC dba Cascade Skagit Health Alliance from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Alliance's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

INFORMATION ABOUT THE ALLIANCE

Smokey Point Medical Center, LLC, doing business as Cascade Skagit Health Alliance, was created through an interlocal agreement in 2012 and is owned 50% by Skagit County Public Hospital District No. 1 and 50% by Snohomish County Public Hospital District No. 3. The Alliance operates a two-story, 40,000-square-foot ambulatory center. Approximately one quarter of the space is leased to UW Medicine, which operates a primary care physician practice and a maternal fetal medicine clinic. The rest of the building is leased to Skagit County Public Hospital District No. 1, which operates an outpatient chemotherapy unit, an urgent care clinic, an occupational medicine clinic, and laboratory and imaging services.

The Alliance is governed by a managing board composed of two representatives from each hospital district.
