## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the City of Pacific from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement
- Cost allocation

## INFORMATION ABOUT THE CITY

The City of Pacific serves approximately 7,034 residents and is located on the border of King and Pierce counties. The City provides services including police, utilities (water, sewer, and storm drainage), parks, public works, community development and planning, senior and youth programs, and a Municipal Court.

The City operates under a mayor-council form of government with an elected, seven-member Council and an independently elected Mayor. The Council appoints management to oversee the City's daily operations as well as its approximately 38 employees. For fiscal year 2016, the City operated on an annual budget of approximately \$30.3 million.
