## AUDIT SUMMARY

### Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to the District management in a letter dated February 15, 2018, related to procurement. We appreciate the District's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of Grant County Fire Protection District No. 8 from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billings for fire protection services and ambulance services
- Open public meeting minutes
- Bid law compliance
- Cash receipting for locally receipted funds
- General Disbursements including fuel cards and credit cards

## INFORMATION ABOUT THE DISTRICT

Grant County Fire Protection District No. 8 was formed in 1959 to provide fire protection and suppression services to residents living within its service boundaries. In 1977 the District began providing ambulance services.

The District operates on an annual budget of approximately \$1,400,000. The District has two full-time employees and more than 30 volunteer firefighters. An elected, five-member Board of Commissioners governs the District.
