AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Poulsbo Fire Department from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self- insurance unemployment compensation
- Ambulance billing
- Financial condition

- Payroll/personnel
- Cash receipting
- Annual report filing

INFORMATION ABOUT THE DISTRICT

Kitsap County Fire Protection District No. 18, formed in February 1961, provides fire protection services to the general public. In November 1999, the District annexed the City of Poulsbo. The District covers 54 square miles, including the city of Poulsbo, and provides fire, medical and rescue services as well as a full line of fire protection and public education programs.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as its 49 employees. The District is funded primarily through property taxes with an operating budget of approximately \$6.8 million for 2015 and \$7 million for 2016.
