AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Pasco from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Sale of land
- Payroll new hires and employees with large increases
- Credit Cards policy, procedures, and allowable purchases
- Compliance with third party cash receipting contract with Paymentus
- Cash receipting for the utility department

- Municipal court system review
- Municipal court non-cash adjustments
- Municipal court receipting
- General disbursements and review of new vendors
- Building permits billing and allowable use of revenues

INFORMATION ABOUT THE CITY

The City of Pasco, incorporated in 1891, currently serves approximately 54,500 Franklin County citizens. The City provides services including police, fire, Municipal Court, emergency response, parks and recreation, a senior center, a golf course, public works, and planning and economic development. The City also operates a cemetery, a water system, sewer system and an irrigation system.

An elected, seven-member Council governs the City. The Council selects one of its members to serve as Mayor. The Council also appoints management to oversee the City's daily operations as well as its approximate 296 employees. The City had approximately \$63 million in expenditures for 2016.
