#### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Pierce County Flood Control Zone District from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounting/financial reporting
- Capital Projects scope requirements
- Financial condition

#### INFORMATION ABOUT THE DISTRICT

The Pierce County Council authorized Ordinance 2011-95s, which created the Pierce County Flood Control Zone District (PCFCZD), to address some flood management needs.

The PCFCZD is a special purpose district governed by a Board of Supervisors and an Executive Committee. They receive input and recommendations from an Advisory Committee. The Pierce County's Department of Public Works carries out the District's approved projects and programs. During fiscal year 2015 and 2016, the District budgeted \$7,717,304 and \$7,861,531 for flood projects accordingly.
