## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the City of Davenport from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Insurance/risk management
- Municpal Airport Department
- Payments/expenditures

- Financial condition
- Contracts/agreements

The City of Davenport, incorporated in 1890, serves approximately 1,740 citizens in Lincoln County. The City has seven full-time employees who provide water, sewer, garbage, street, parks and recreation, planning and economic development and general administrative services. The City also operates an airport, library and cemetery.

An elected, seven-member Council and an independently elected Mayor govern the City. The City had expenditures of approximately \$2.3 million, \$2.3 million and \$2.8 million for fiscal years 2014, 2015 and 2016, respectively.
