#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, except as described below, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to City management and Mayor and City Council in a letter dated March 8, 2018, related to the procurement of professional services and purchases. We appreciate the City's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of the City of Elma from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2016, 2015 and 2014, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Compliance with Open Public Meetings Act
- Financial condition
- Controls over cash receipting and utility billing
- Interfund cost allocation plan
- Procurement public works, architecture and engineering, purchases

- Self-insurance unemployment compensation
- Small and attractive assets citywide controls and testing
- Police Department cash receipting, citations, and custody of evidence
- General disbursements controls and testing

The City of Elma serves 3,150 citizens in Grays Harbor County.

It is administered by a mayor-council form of government with an elected, five-member City Council and an independently elected Mayor. The City has 30 employees who provide a full range of services including police, parks and recreation, planning and economic development, street maintenance and construction, judicial administration and water and sewer services. For fiscal years 2014, 2015 and 2016 the City operated on an annual budget of \$6,838,801, \$6,655,224 and \$7,643,524, respectively.
