AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of King County Fire Protection District No. 40 from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Use of restricted funds for allowable purposes
- Contract monitoring
- Financial condition and fiscal sustainability

INFORMATION ABOUT THE DISTRICT

In 2008, King County Fire District No 40 contracted the Renton Regional Fire Authority to provide fire protection services to the District's 8 square-mile service area bordered by the cities of Renton, Tukwila, Maple Valley and Kent. The District primarily serves a residential area and some commercial establishments.

An elected, five-member Board of Commissioners governs the District. The Fire Chief and District Secretary supervise daily operations. The District maintains one fire station, which is managed by the City of Renton. The District's operating revenues for 2016 were approximately \$6 million.
