AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Port of Kingston from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Finance charges – marina billing
- Leases
- Small and attractive assets
- Cash receipting
- Disbursements/credit cards

INFORMATION ABOUT THE PORT

The Port of Kingston was established in 1919. The Port is located on Puget Sound north of Seattle. The Port is comprised of 10 acres of submerged land and 12 acres of uplands, in which the Washington State Ferries leases four acres. The Port has a number of waterfront facilities including Mike Wallace Park, beach access, fuel dock, performing arts stage for events, 14 slip kayak facility, 260 permanent boat slips, a guest dock, a boat launch ramp, paid parking and a public fishing pier. The Port is authorized to develop and facilitate transportation and economic development programs and promote tourism.

An elected, three-member Board of Commissioners administers the Port. Board Members serve six-year terms. For fiscal years 2015 and 2016, the Port operated on an average annual budget of approximately \$2,000,000.
