## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the Grays Harbor Conservation District from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2016, 2015 and 2014, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings minutes
- Payroll – controls, gross wage recalculation, leave accruals and leave balances
- Controls over disbursements
- Compliance with state grant requirements
- Financial condition and fiscal sustainability

## INFORMATION ABOUT THE DISTRICT

The Grays Harbor Conservation District protects, preserves and enhances the many natural resources, as well as promotes the implementation of proven environmental practices, within its boundaries in Grays Harbor County. The District has five employees.

A five-member Board of Supervisors governs the District. Board Members are appointed by the State Conservation Commission. It operated on a budget of approximately \$210,000 in 2014, \$820,000 in 2015 and \$611,000 in 2016.
