#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

Because public distribution of tests performed and the related results over information technology could increase the risk to the District's IT security, distribution of that information has been limited to management and the governing body of the District and is kept confidential under RCW 42.56.420.

#### About the audit

This report contains the results of our independent accountability audit of Chimacum School District No. 49 from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body review of student council minutes and program budget compliance for the high school and middle school
- Asset tracking of small and attractive assets such as computers and laptops
- Financial condition and fiscal sustainability

- Procurement for public works projects – high school roof replacement
- IT security for Skyward applications password configuration, generic log-ins and former employee access

Chimacum School District No. 49, located in Jefferson County, operates a primary school, elementary school, middle school and high school. The District serves approximately 1,024 students with a staff of approximately 120 full-time employees.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent who oversees the District's daily operations. The District operates on a \$14 million annual budget.
