#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Network operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of the Medical Information Network - North Sound from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Network's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements, credit card activity and travel expenditures
- Statutory authority for operations

#### INFORMATION ABOUT THE DISTRICT

Based in Mount Vernon, Washington, Medical Information Network – North Sound (MIN-NS) was formally organized June 30, 2008 as a non-profit corporation pursuant to state law (RCW 24.06) for the purpose of electronically connecting patients, providers and others to a regional electronic health record system to improve the quality and efficiency of health care services in North Sound communities. MIN-NS is currently supported by two public hospital district founders, Skagit County Public Hospital District No. 1 (dba Skagit Regional Health) and Skagit County Public Hospital District No. 2 (dba Island Hospital).

A four-member Board of Directors serves as the governing body and oversees approximately 10 employees. For fiscal years 2015, 2016 and 2017 operating expenses were \$2,244,738, \$2,260,484 and \$1,827,961, respectively.
