AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Commission operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Washington State Criminal Justice Training Commission from July 1, 2013 through June 30, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the State Auditor to examine the financial affairs of all state agencies. Our audit involved performing procedures to obtain evidence about the Commission's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended June 30, 2017, 2016, 2015 and 2014, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

• Restricted Funds

• Disbursements

• Contracts

• Travel

• Payroll

INFORMATION ABOUT THE COMMISSION

The Washington State Criminal Justice Training Commission provides training for law enforcement, corrections and other public safety professionals in Washington State. Although the majority of the training takes place at the Burien facility, the Commission also works with local jurisdictions to develop quality training throughout the state. The Commission consists of 14 members, 11 of whom are appointed by the Governor. The remaining three members are the Attorney General, the Chief of the State Patrol and the special agent in charge of the Seattle office of the Federal Bureau of Investigation. The Commission is responsible for adopting rules and regulations and establishing standards for the training of criminal justice personnel. It also appoints the Commission's Executive Director.

The Commission is funded primarily through the state's general fund with the 2017-2019 biennium appropriation of approximately \$57 million. In addition, the Commission collects revenue through fees for services. During the 2015-2017 biennium, it brought in \$6,000,000 in revenue. The Commission has 54 employees who administer and conduct the activities of the Commission.
