AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Stanwood-Camano School District No. 401 from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement of computer purchases and IT security measures
- Fuel contracts and cards
- Basic enrollment

- Self-insurance assessment
- Financial condition
- Open Public Meetings Act

INFORMATION ABOUT THE DISTRICT

Stanwood-Camano School District No. 401 serves approximately 4,400 students in kindergarten through 12th grade. The District includes the northwest portion of Snohomish County, as well as Camano Island of Island County. The District operates five elementary schools, two middle schools, one high school, an alternative middle school and high school, a variety of on-line courses, and a parent-partnered educational program/school. In addition, the District provides services for preschoolers with developmental delays.

An elected, five-member Board of Directors governs the District. Directors serve four-year, staggered terms. A Board-appointed Superintendent oversees the District's daily operations as well as its staff of approximately 600 employees. For fiscal year 2017, the District had approximately \$51.9 million in total expenditures.
