AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, except as described below, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Directors in a letter dated April 3, 2018, related to procurement of architectural and engineering services. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Toutle Lake School District No. 130 from September 1, 2014 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body (ASB) cash receipting and fundraising activities
- Procurement of public works and architectural and engineering services for the Modernization Project, including prevailing wages
- Disbursement general vendor payments and employee reimbursements
- Payroll gross pay recalculation, leave accruals and cashouts

INFORMATION ABOUT THE DISTRICT

Toutle Lake School District No. 130 serves approximately 580 students in kindergarten through 12th grade. Located in Cowlitz County, the District operates one elementary school and one secondary school.

An elected, five-member Board of Directors has oversight for the District, appointing management, setting the budget and holding other fiscal responsibilities. The District operates on an annual budgets of \$14.8 million for fiscal years 2017, respectively, and has a staff of approximately 80 employees.
