AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

Because public distribution of tests performed and the related results over information technology could increase the risk to the District's IT security, distribution of that information has been limited to management and the governing body of the District and is kept confidential under RCW 42.56.420.

About the audit

This report contains the results of our independent accountability audit of Pullman School District No. 267 from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Self-insurance dental, vision and unemployment
- Compliance with contracts artwork project
- IT systems review of user access
- Procurement purchase cooperatives, public works (Kamiak Elementary School), and land purchase

INFORMATION ABOUT THE DISTRICT

Pullman School District No. 267 serves approximately 2,650 students in kindergarten through 12th grade in Whitman County. The District has three elementary schools, one middle school and one high school.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent and Assistant Superintendent who are responsible for the day-to-day operations as well as its 350 employees. For fiscal year 2017, the District operated on an annual general fund budget of approximately \$29 million.
