AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, except as described below, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Directors in a letter dated May 16, 2018, related to internal controls over Associated Student Body fundraisers and gate receipts. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of North Mason School District No. 403 from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Basic enrollment at North Mason High School
- General disbursements and credit card activity
- Financial condition and fiscal sustainability
- Associated Student Body fundraisers and athletic gate receipts at North Mason High School

INFORMATION ABOUT THE DISTRICT

North Mason School District No. 403 serves approximately 2,100 students in kindergarten through 12th grade in Mason County. The District operates one high school, one alternative high school, one middle school and two elementary schools.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 250 employees. The District had an operating budget of \$25 million for 2016 - 2017 School Year.
