AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Monroe School District No. 103 from September 1, 2015 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Enrollment basic at Monroe High School, bilingual at multiple elementary schools and Park Place middle School
- Procurement purchases and professional services
- Tracking of small and attractive assets
- Self-insurance property, health and welfare, workers compensation and unemployment
- Selected IT policies, procedures, practices, and controls protecting financial systems, IT systems, and data
- Authority and involvement in the Monroe Community Coalition
- Evaluated design of controls over disbursements

INFORMATION ABOUT THE DISTRICT

Monroe School District No. 103 provides public school services to approximately 6,720 students in kindergarten through 12th grade in Snohomish County. The District has five elementary schools, two middle schools, two alternative schools and one high school.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its staff of 610 employees. For the 2017 fiscal year, the District's general fund expenditures totaled \$74,754,156. The Monroe School District is located in Snohomish County and serves a population of over 16,000 people.
