AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Olympic Educational Service District No. 114 from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition – evaluated financial condition and District's sustainability for all funds
- Payroll Disbursements – examined large payroll disbursements for validity and correct calculation.
- Procurement for purchases – evaluated whether District follows its own policies and procedures
- Accounts receivable – confirmed payments for accounts receivable were received

RELATED REPORTS

Financial

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the District's financial statements. That report is available on our website, <http://portal.sao.wa.gov/ReportSearch>.

That report includes a finding for a significant deficiency in internal controls over financial reporting regarding liabilities related to other post-employment benefits that were not recorded in accordance with government accounting standards.

Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE DISTRICT

Olympic Educational Service District No. 114 provides services to 15 school districts within Kitsap, Mason, Jefferson and Clallam counties. It offers numerous educational programs, which include special education, Head Start, detention centers, youth substance abuse and treatment counseling, and instructional materials for the Workforce Investment Act. As a member and manager of the Western Regional Information Services Center, the District provides financial management, human resource, payroll, and student services to 15 school districts in four counties.

A seven-member Board of Directors governs the District. Board Members are elected at large by their respective local school boards. The Board appoints a Superintendent to oversee the District's daily operations as well as its over 364 employees. For fiscal year-end 2017, the District's Operating Fund annual operating expenses were almost \$17.2 million.
