AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Normandy Park Metropolitan Park District from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Legal authority to operate a preschool and the Policing the Parks programs
- General disbursements interlocal agreement quarterly payments

INFORMATION ABOUT THE DISTRICT

The Normandy Park Metropolitan Parks District was formally approved by the voters of Normandy Park on November 3, 2009. The City of Normandy Park's Council act as the Ex Officio Board of Metropolitan Park Commissioners. The District provides parks and recreation services by contracting through an interlocal agreement with the City of Normandy Park.

The City of Normandy Park owns and operates all parks and recreation programs within the City and the District. The City has the authority to determine the scope, variety, facilities and programs for parks and recreation. The District is a separate taxing authority. The District uses single-entry, cash basis accounting which is a departure from generally accepted accounting principles (GAAP).

The District's annual revenues for 2016 and 2015 were approximately \$612,000 and \$629,000, respectively.
