AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, except as described below, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Directors in a letter dated May 17, 2018, related to the facilities department tracking of small and attractive assets and fuel usage. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of North Kitsap School District No. 400 from September 1, 2016 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- IT Risks user access to financial and student data in Skyward
- Basic enrollment reported FTE at Poulsbo Middle School and Kingston High School
- Self-insurance vision insurance
- Small and attractive assets, fuel usage, tracking of supplies and materials, and
- Evaluation of the District's financial condition and sustainability
- Payroll large pay increases, leave payouts and bus driver payroll
- General disbursements and Amazon purchases using District credit cards

- Tracking of IT assets at Poulsbo Middle School
- Procurement public works and change orders

INFORMATION ABOUT THE DISTRICT

North Kitsap School District No. 400 is located on the northern tip of the Kitsap Peninsula which includes the communities of Poulsbo, Kingston, Hansville, Indianola and Suquamish. The District provides basic education and related services to approximately 6,065 students in kindergarten through 12th grade. The District operates six elementary schools, two middle schools, two high schools, the Spectrum Community School, West Sound Vocational Skills Center and the Running Start program with Olympic College.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 860 employees. For fiscal year 2017, the District operated on an annual budget of approximately \$76 million.
