AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Langley from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement for architectural and engineering services
- Payments out of restricted utility funds
- Grant account codes
- Contracts and agreements

- Open Public Meetings Act and review of the Citizen Boards
- Cash receipting at the front desk
- General disbursements including employee reimbursements and credit card transactions

INFORMATION ABOUT THE CITY

The City of Langley has a population of approximately 1,045 residents and is located on Whidbey Island in Island County. The City provides an array of services including police protection, library services, cemetery services, water distribution, sewage collection and treatment, street maintenance, park maintenance, planning and zoning and general government services. The City's economy is based primarily on tourism, commercial and service activities.

An elected, five-member Council and a separately elected Mayor govern the City. The Council appoints management to oversee the District's daily operations as well as its 19 employees. For fiscal years 2015 and 2016, the City had annual expenditures of \$3.3 and \$3.5 million, respectively.
